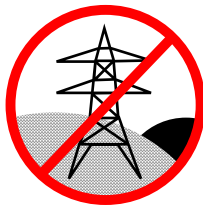

I understand that Green Gen Cymru has now been granted an IDNO licence by Ofgem. I expect landowners will see threatening letters and aggressive land agent visits as a result.

The Welsh Government's position is for electricity transmission cables to be placed underground. When will the policy/wording be updated to close the "where possible" loophole and what can be done to accelerate this process?

Will you apply pressure on the Welsh Pension Partnership to withdraw funding from Bute Energy to help put a stop to their plans?

And finally, what more can be done to protect our rural communities who are now left extremely exposed by Ofgem's decision?
